SPRING TRAINING FEE –

- Yes please register my child for Spring Training. Spring training will begin as soon as the weather permits. The program will initially start for the older more experienced paddlers (bantam and up) and then as the water warms and conditions improve the younger age groups will be invited to attend via email notification.

LUNCH SUPERVISION - \$50.00 for Entire Summer:

- Yes I require lunch supervision daily. I will notify the club in writing if my child has permission to leave the club at lunch.
- No I do not require lunch supervision for my child on a regular basis. My child will travel to and from the club during the lunch hour. The Gananoque Canoe Club is not responsible for my child during this time. Should I require lunch supervision I will notify the club and pay **\$2 per day** in advance.

BEFORE & AFTER CARE

The traditional program runs from Monday to Friday, 10am until 3pm. To facilitate memberships that require extended care hours we will be offering before and after care for the 2012 season. The Before & After Care will run between the hours of 8am-10am, and 3pm-5pm at a cost of \$25.00 per child/week. If you require this service please complete the Before & After Care Registration Form copied on the back of this form.

MANDATORY FUNDRAISER

At registration each family will be required to pay \$50.00 for 30 raffle tickets. Money will be recouped upon sale of your tickets, or you can choose to purchase them yourselves. The Raffle will be for a \$500.00 cash prize to be drawn at the Gananoque Regatta in July.

MANDATORY VOLUNTEER HOURS ***

The running of a non-profit youth organization takes countless hours of volunteer time. The Gananoque Canoe Club needs the help of each and every family to keep the organization strong and growing. To keep the work load more equitable and keep the burnout factor low there is a mandatory 10 hour volunteer commitment required by each family. A \$100 volunteer deposit is required at the time of registration. Upon completion of the volunteer commitment a refund will be issued. Each family is encouraged to pick a project or a committee and get involved.
